### Leading US agriculture cooperative joins BASF Living Acres initiative to help create monarch butterfly habitats

RESEARCH TRIANGLE PARK, NC and INVER GROVE HEIGHTS, MN, May 1, 2017 – CHS Inc. (NASDAQ: CHSCP, CHSCO, CHSCN, CHSCM, CHSCL), the nation's leading farmer-owned cooperative and a global energy, grains, and foods company, gave flight today to its commitment behind the Living Acres Monarch Challenge. BASF's research-based initiative provides actionable guidance for farmers and rural communities looking to cultivate monarch butterfly habitat.

To kick-off the initiative, CHS Inc. hosted a pollinator-friendly planting at its Minnesota headquarters, expanding on the already-established native landscape on the campus.

"Restoring the monarch butterfly population will require collaboration with various entities and landowners throughout the agriculture industry," said Scott Kay, BASF, Vice President, U.S. Crop. "By partnering with CHS and their vast network of farmer-owners across key monarch migration states, we can truly make a difference together."

BASF developed the Living Acres program in 2015 with the initial goal of helping to restore the monarch population. The Monarch Challenge represents the next step in sharing best practices on milkweed development with farmers to help support the species.
